IN THE MUNICIPAL COURT STATE OF TEXAS COUNTY OF TRAVIS CITY OF AUSTIN, TEXAS AFFIDAVIT FOR SEARCH WARRANT Before me, the undersigned authority, on this day personally appeared Officer GLEBERT 5346 who after being duly sworn upon oath deposes and says: I am a peace officer of the State of Texas, to wit: a Police Officer for the City of Austin in Travis County, Texas, and I have good reason to believe that heretofore, on SEP 11, 2012 at approximately 10 : 447 in the County of Travis and State of Texas, Jonathan Stick (White / Male born 02/27/1966, height 506, weight 145, DL , did then and there commit an offense relating to the operation of a motor vehicle while intoxicated namely: DRIVING WHILE INTOXICATED - (OFFENSE LEVEL Class B) Affiant has probable cause for said belief by reason of the following facts: My belief of the foregoing statement is based upon 17 personal knowledge 17 information provided to me by Officer , an officer working for who personally observed such offense such offense. GILBERT **P**Officer 5346 , observed Jonathan Stick (White / Male born 02/27/1966, height 506, weight [45, D] Schröding Coperating 2009 Black GMC Yukon ULLINSON, neight operating 2009 Black GMC Yukon upon 500 Block Campbell, a public place in Austin, Travis County, TX On SEP 11, 2012 at approximately 10 : 44 P. Officer GILGERT 5346 Stopped Contacted Januthan Stick (White / Male born 02/27/1966, height 506, weight 145, DL. for the following reasons: Subject was driving westbound in the 1000 block of W 6th St at a high rate of speed. I checked the vehicle at 45 mph using stationary radur. The posted speed limit in the 1000 block is 30 mph. The vehicle then moved from the left

lane to the center lane without signaling any intent. The vehicle followed a slower moving car at an ansafe distance (less than I car length). In about the 1300-1400 block of W 6th St the vehicle drifted back and forth the left, crossing the lane line into the left lane as well as straddling the lane line as the vehicle continued westbound. In about the 1500 block the vehicle failed to signal intent again when it moved from the center lane to the left lane. When the vehicle stopped at the red light at the intersection of W 6th and West Lynn it failed to stop at the designated point,

stopped well past the clearly marked stop line, past the first crosswalk line and into the intersection.
