UNIVERSITY OF TEXAS LAW SCHOOL FOUNDATION SUMMARY

The University of Texas Law School Foundation is a private, non-profit, and educational corporation, established on June 13, 1952. The mission of the Law School Foundation is the development, management, and enhancement of financial and administrative resources which support The University of Texas School of Law. To fulfill our mission, we are dedicated to:

- Identification, solicitation, and stewardship of donors for the funding of Law School programs, such as the Annual Fund (unrestricted and operational resources), Capital Programs (endowed chairs, professorships, lectureships, and scholarships), Special Projects (building funds, faculty research, and special endowment campaigns), and Planned Giving (wills, bequests, estates, and trusts);
- Collecting, accounting, acknowledging, investing, disbursing, and reporting of funds raised for such objectives, in the most efficient, expeditious, beneficial, and prudent manner possible;
- Assisting the Dean, faculty, and students of the School of Law in achieving their goals and objectives, whenever possible and appropriate;
- Cooperating and coordinating with The University of Texas at Austin Development Board for the advancement of the general welfare of The University of Texas as a whole.

The Foundation maintains three categories of funds – Endowment funds, Non-endowed restricted funds and Unrestricted funds. Endowment funds are permanent, substantial gifts which must be maintained in perpetuity. Non-endowed restricted funds may be one time gifts or gifts given over a period of time but all funds may be used for their designated purpose upon receipt. Unrestricted funds result from earnings on investments, oil and gas royalties and gifts from donors.

Both endowed and non-endowed restricted funds must be used for the purpose designated by the donor. The major purposes of which are to fund:

- Chairs
- Scholarships
- Research Centers within the Law School
- Faculty recruitment and retention

Unrestricted funds may be used at the Board of Trustee's discretion. Historically, these funds have been used for:

- Foundation operations
- Fundraising efforts
- Initiatives of the Dean of the Law School such as student scholarships, student loan repayment programs, student recruitment, student organization support and faculty support.

The Foundation currently manages over \$175 million in assets for the sole benefit of the Law School. Over the past 10 years alone, the Foundation has donated over \$80 million (net of the remaining \$175 million) to the financial support of the Texas Law School and its students. Foundation contributions to the Law School now exceed \$9 million annually. This represents nearly 17% of the annual Law School budget and approximates the financial support received by the Law School from the State's non-tuition revenues.

NOTE: This is an example of what is included in each book prepared for the Board of Trustees' meetings. This summary, particularly the portion at the bottom, describes the budget process at the UT Law School Foundation. Twelve of the Foundation's 31 voting Trustees currently serve on the Budget Committee.

Executive Summary

The Law School Foundation's operating budget is reviewed and recommended by the Budget Committee and presented to the Board for approval. The Foundation has two types of operating funds, endowed and non-endowed. Our endowed funds are restricted by the donors and are to be held in perpetuity. The Foundation's current spending policy is 4.3% for 2014-15 and is based on the average market value of the previous 12 quarters.

The non-endowed operating budget is comprised of both unrestricted and restricted funds. Unrestricted funds can be used for any purpose authorized by the Board. The Annual Fund, earnings from investments, and oil and gas royalties are the primary sources of unrestricted funds. Restricted funds are gifts that have been specified by the donors to be spent for a particular purpose. These funds often are one-time gifts, but they also can be a form of continuing support for particular programs or initiatives.

UT LAW SCHOOL FOUNDATION

Changes to Processes and Controls of Foundation

In March 2014, the University of Texas Law School Foundation (the Foundation) hired an independent Chief Financial Officer (CFO) in order to create a more definitive separation of the Foundation from the Law School. The CFO reports directly to the Foundation's Board of Trustees. Procedures have been established whereby the CFO and/or the President or Vice President of the Foundation, depending on level of spending, approves all expenditures of the Foundation including those to the University of Texas Law School (the Law School). Additionally, the CFO ensures that expenses conform to the budget as approved by the Board of Trustees. Please see separate page on the budget approval process.

Beginning in fiscal year 2015, support of the Law School by the Foundation will be accomplished almost entirely through reimbursement to the Law School. Except for certain items noted below, expenditures will be made by the Law School, following their processes and policies, and the Law School will request reimbursement from the Foundation where appropriate funding exists. The following items will continue to be paid directly from the Foundation:

- Stipends to certain highly recruited students to attend Admitted Student's Day
- Subscriptions for the library held in the Foundation's name
- Amounts related to contracts held in the Foundation's name
- Certain promotional items and/or gifts to alumni and students

Any expenses that relate to the operation of the Foundation such as salaries of the Foundation staff, insurance, audit, supplies, etc. will be paid directly by the Foundation.
