
### JANA DUTY'S CHOICES



#### ANTHONY BLACKMON

Blackmon's former girlfriend, and mother of four, was denied a protective order by the County Attorney's office in May 2011. In October 2011, Blackmon shot her to death in her home before he turned the gun on police.



#### **DARIUS DAVIS**

The County Attorney dismissed a misdemeanor in April 2011 and ended his juvenile probation, before he went on a felony crime spree in late 2011. He was convicted of burglary, aggravated robbery, assault on a public servant, unauthorized use of a vehicle and credit card abuse.



#### JUVENILE MENTIONED IN LETTER AT RIGHT

The County Attorney refused the District Attorney's request to try the juvenile who provided ecstasy as an adult. Even though he had previously been charged with theft, possession of drug paraphernalia, possession of alcohol by a minor, consumption of alcohol by a minor and curfew violation; he was simply given probation until his 18th birthday in May 2012.

#### **Dear Fellow Williamson County Residents:**

Last March, my wife and I lost our 16 year-old son, Joey, in a tragic and senseless manner. Over one weekend, he was given ecstasy by a schoolmate and prescription methadone by a friend's mother. The combination of the two took his young life. There are words for when you lose a parent or spouse, but there is not a word in the English language for losing a child.

The mother who gave Joey the methadone was convicted of delivering drugs to a minor and is serving 30 years in prison. She also gave the medication to her daughter and two other teens. We are very thankful for District Attorney John Bradley's efforts in prosecuting this case and holding this individual accountable.

Jana Duty, the County Attorney, handled the prosecution of the juvenile who provided the ecstasy. She ignored the request of the District Attorney's office to certify him as an adult, and simply put him on juvenile probation. When he turns 18 this month, his supervision will end. He's free and clear. What's to stop him from continuing to distribute dangerous illegal drugs?

No punishment can make up for the loss of our son, but Wilco residents need to realize the choice they have at the ballot box and why we are voting for John Bradley. Over this last year, we have come to understand Jana Duty often chooses the more lenient punishments for offenders. Unfortunately for Williamson County families, the offenders she ignores go on to commit more grievous crimes. No clearer examples exist of the choice that voters have. Please join us in voting to keep experienced prosecutor John Bradley as Williamson County District Attorney.
