You agree that appropriate representatives of the Republican Conference of the Texas Senate will be reasonably available to confer with us upon request, will provide us with such documents and information as you may possess relating to the matter, will disclose all facts and circumstances of which you are aware that may bear upon our handling of the matter, will promptly pay our fees in accordance with the terms of this letter, and will otherwise assist our efforts as we reasonably request.

SCOPE OF REPRESENTATION

We are confident that our services in this matter will prove beneficial and we hope that you will seek our assistance with other matters in the future. However, our present agreement to provide legal services to the Republican Conference of the Texas Senate is limited to the matter, described above, for which you have engaged us. As you are aware, we are a large law firm, and we represent many other companies and individuals. It is possible that some of our present or future clients will have disputes or other dealings with the Republican Conference of the Texas Senate during the time that we are representing the Republican Conference of the Texas Senate. Accordingly, as a condition of our undertaking this matter for you, you agree that this Firm may continue to represent, or may undertake in the future to represent, existing or new clients in any matter, including litigation, that is not substantially related to our work for the Republican Conference of the Texas Senate, even if the interests of such clients in those other matters are directly adverse to the Republican Conference of the Texas Senate. Where ethically permissible to do so, we agree to notify you of each such representation as it arises. We agree, however, that your prospective consent to conflicting representations shall not apply in any instance where, as the result of our representation of the Republican Conference of the Texas Senate, we have obtained sensitive, proprietary or other confidential information of a non-public nature that, if known to another client of ours, could be used to the material disadvantage of the Republican Conference of the Texas Senate in a matter in which we represent, or in the future are asked to undertake representation of, that client.

RETAINER

It is customary for Morgan, Lewis & Bockius LLP to require the payment of a retainer in undertaking a new representation. We have not requested a retainer in connection with this representation. However, if our bills are not paid when due, or if the representation proves to be substantially more complex or time-consuming than our initial discussions would indicate, we may ask, as a condition of our continuing this engagement, that you deposit a retainer to be applied against ongoing fees and expenses on terms that will be agreed upon at that time.
