FINAL SUMMARY JUDGMENT

The Court heard Plaintiffs' Motion for Final Summary Judgment. After considering the pleadings, motion, evidence on file, and oral arguments of counsel, if any, the Court GRANTS the motion.

The Court hereby RENDERS judgment for Plaintiffs.

Accordingly, the Court orders that Plaintiffs recover the following from Defendants:

- a. Actual damages in the amount of \$27,500.00.
- b. Exemplary damages in the amount of \$50,000.00
- c. Prejudgment interest on the actual damages awarded at the rate of 5% from January 15, 2015 until March 10, 2016, in the amount of \$1,375.00
- d. Reasonable and necessary attorney fees in the amount of \$16,625.00 for the prosecution of this case through this judgment.
- e. Postjudgment interest on all of the above at the rate of 5%, compounded annually, from the date this judgment is entered until all amounts are paid in full.

The Court further orders that if defendants unsuccessfully appeal this judgment to an intermediate court of appeals, plaintiffs will additionally recover from defendants the amount of \$4,500.00, representing the anticipated reasonably and necessary fees and expenses that would be incurred by plaintiffs in defending the appeal.

The Court further orders that if defendants unsuccessfully appeal this judgment to the Texas Supreme Court, plaintiffs will additionally recover from defendants the amount of \$4,500.00, representing the anticipated reasonably and necessary fees and expenses that would be incurred by plaintiffs in defending the appeal.

This judgment finally disposes of all claims and all parties, and is appealable.

The Court orders execution to issue for this judgment.
