1986 <sup>1</sup>	August	Cumberland Memorial Hospital (WI)	“patient has schizoid quality about him”; “appears to be on the edge of a psychotic break”. “Feels he is controlled by an unseen power.” “Patient has fears that the devil is after him.” “Hears Bob Dylan music in his head.” “Suicidal thoughts.” Patient’s “expectation of hospitalization is that he will be medicated so that he doesn’t hear voices anymore.”	Depression, brain dysfunction, delusions, auditory hallucinations, <del>homicidal ideations towards his family</del>
