PLAINTIFF'S ORIGINAL PETITION

1. Plaintiff City of Fort Worth alleges that discovery in this cause should be conducted under Level 3 of Texas Rule of Civil Procedure 190.4 and urges the Court to act on entering a Discovery Control Plan for this matter as promptly as reasonably possible.

Summary of This Action

The City of Fort Worth is the 5th largest city in Texas. According to the 2. most recent census, about 741,000 people live in Fort Worth. The citizens of Fort Worth take great pride in the quality of life in Fort Worth, including reliable police and fire services, good schools, clean and well maintained streets, and safe parks. Fort Worth also does business in an open, ethical and honorable manner and it honors its contracts in letter and spirit. In turn, the City expects its business partners to do the same. Fort Worth regrettably brings this action against Chesapeake and Total because they have fallen well short of their obligations to the City and its citizens, including willfully and knowingly violating express and/or implied duties owed to the City in connection with various oil and gas leases the City executed to permit the exploration and production of minerals located under City lands. Chesapeake and Total, acting as lessees and

Chesapeake acting as operator, have substantially underpaid the City royalty payments owed under various oil and gas leases through the use of sham sales to affiliates and/or by improperly deducting costs of gas gathering, transportation, separation, treatment and other production services. The City therefore seeks to obtain true and complete production, pricing, sales and related information pertaining to its minerals so that the City can (a) quantify the total amount of underpayments by Chesapeake and Total, (b) recover a judgment against Chesapeake and Total for the amount of the underpayments, and (c) obtain declaratory relief.

Parties

- 3. Plaintiff, City of Fort Worth ("the City" or "Fort Worth"), is a municipal corporation located in Tarrant County, Texas, duly incorporated, organized, and existing under and by virtue of a special charter adopted by the qualified voters of the City pursuant to the power vested in those voters by the laws and Constitution of the State of Texas.
- 4. Chesapeake Operating, Inc. ("Chesapeake Operating") is a corporation organized under Oklahoma law with its principal place of business in Oklahoma City, Oklahoma. Chesapeake Operating, Inc. should be served with a copy of the Original Petition and Citation by serving CT Corporation System, 350 North St. Paul Street, Suite 2900, Dallas, Texas 75201-4234.
- 5. Defendant Total E&P USA, Inc. ("Total") is a corporation organized and existing under the laws of the State of Delaware, with its principal place of business in Houston, Harris County, Texas. Total may be served with a copy of the Original Petition

and Citation by serving its registered agent, CT Corporation, 350 N. St. Paul Street, Suite 2900, Dallas, Texas 75201.

- 6. The City of Fort Worth asserts claims in this cause that are within the jurisdictional limits of a district court in Tarrant County, Texas. The City seeks monetary relief over \$1 million together with other relief.
- 7. Venue is mandatory in Tarrant County because the City seeks to recover real property or an estate or an interest in real property pursuant to §15.011 of the Texas Civil Practice & Remedies Code. Venue is further proper in Tarrant County pursuant to §15.002(a)(1) because Tarrant County is the county in which all or a substantial part of the events or omissions giving rise to the City's claims occurred.

The Leases

8. Fort Worth owns mineral interests under its lands. Several years ago, Fort Worth was approached by various oil and gas operators, including by way of illustration, Chesapeake Exploration, LLC, Dale Property Services, LLC and Four Sevens Oil Co., Ltd., each of whom expressed interest in leasing the City's mineral interests for the purpose of drilling and producing oil and natural gas. Subsequently, Fort Worth entered into leases of its minerals for the benefit of its citizens. Chesapeake and Total now purport to hold the rights of Lessee under the leases listed on the attached Exhibit A ("Leases"). Importantly, each of the Leases obligate Lessee to pay Fort Worth a royalty on the higher of (a) the proceeds from the sale of oil, gas, casinghead gas and any other liquid or gaseous hydrocarbons, or (b) the market value thereof. The royalty percentage varies from 25% to 27.5% depending upon the lease. In addition, Chesapeake and Total agreed that the royalties to be paid Fort Worth would "be free of all costs of any kind,

including, but not limited to, costs of gathering, production, transportation, treating, compression, dehydration, processing, marketing, trucking or other expense, directly or indirectly incurred by Lessee." To eliminate any doubt about the ability of the Lessee to avoid its express duties pertaining to payment of royalties, the Leases further specify that the oil, gas or products produced could not be sold to a subsidiary or affiliate of the Lessee without prior written permission from the City.

- 9. The City relied upon the Lessee to develop and produce oil and gas from wells to be drilled and operated on City lands. The Lessee is required to properly measure, test, value and account to the City for all royalties due the City.
- 10. The City's rights of action alleged in this Petition are not barred by any statute of limitations. Tex Civ. Prac. & Rem. Code Ann. § 16.061(a) (Vernon 2008).
- 11. Fort Worth has the right under the Leases to receive full and free access at all times to the books and records of Lessee that pertain to the production and sale of oil, gas or other minerals from the lands covered by the Leases.
- 12. Chesapeake and Total are Lessees and/or Operators of approximately several hundred wells covered by the Leases. Upon information, those wells appear to have produced as of June 30, 2013 more than two hundred billion cubic feet of natural gas from Fort Worth leased lands since first production occurred in approximately 2006. The City of Fort Worth recently discovered that Chesapeake and Total were directly and/or indirectly imposing upon the City costs, including costs of gathering, production, transportation, treating, compression, dehydration, processing, marketing, trucking or other expenses. More significantly, Chesapeake and Total have in bad faith breached the Leases by deducting from royalties paid the City what they call "third party" costs. After

making a limited inquiry, the City discovered that Chesapeake Operating has been selling oil, gas and other liquid and gaseous hydrocarbons covered by the Leases under sham contracts entered into with its affiliate, Chesapeake Energy Marketing, Inc. ("CEMI"). Upon belief, these sham contracts were designed and directed by Chesapeake Energy Corp., a New York stock exchange company and the ultimate parent of Chesapeake Operating and CEMI. The Leases, as noted above, expressly preclude sales of oil, gas or products to any subsidiary or affiliate of Lessee without the City's prior written permission. The City has never granted such permission. Through the use of these sham arrangements among and between affiliates of Chesapeake, Chesapeake and Total have pocketed millions of dollars that belong to the City of Fort Worth and its citizens. The true and full extent of the damages suffered by the City is presently unknown to the City and cannot be known until such time as the City has access to true and complete records of production, pricing, and bona fide sales to unrelated third parties.

under various oil and gas leases of City minerals, Chesapeake and Total by law, and pursuant to the express terms of the Leases, had a duty to reasonably develop the minerals covered by the Leases, to produce those minerals and to market the production from the Leases without influence or regard to the unrelated policy considerations of Chesapeake or Total, or any entity affiliated with either Chesapeake or Total. Chesapeake and Total had a duty to market production from the Leases in the same manner as a reasonably prudent operator unaffected by the considerations of affiliates, would have marketed that production. Notwithstanding, Chesapeake and upon belief, Total, have not acted as a reasonable and prudent operator in making decisions as to the

marketing of production from the City's minerals covered by the Leases, and in deciding how and in what manner the oil, gas or hydrocarbons produced from wells under such Leases would be sold. Instead, Chesapeake and upon belief, Total, have marketed oil, gas, and other hydrocarbons produced from wells situated on the City lands covered by the Leases for reasons of personal gain to Chesapeake and its affiliates and to Total and its affiliates.

Causes of Action

Count One - Breach of Contract

- 14. Fort Worth incorporates by reference all preceding paragraphs.
- 15. The Leases are valid and enforceable contracts governed by the laws of the State of Texas. All conditions precedent, if any, to Fort Worth's claim for relief either have been performed or have occurred.
- 16. Chesapeake and Total have materially breached their contractual obligations to the City including the following express terms:
 - (a) deducting costs from royalties paid the City;
 - (b) imposing directly or indirectly upon royalties paid the City costs of gathering, production, transportation, treating, compression, dehydration, processing, marketing, trucking or other expenses;
 - (c) failing to pay the City a royalty based upon the higher of (a) the proceeds from the bona fide arms length sale of oil, gas, casinghead gas and any other liquid or gaseous hydrocarbons, or (b) the market value thereof;

- (d) failing to pay the City royalties on products based upon the gross market value or proceeds of a bona fide or arms length sale thereof, whichever is higher;
- (e) failing to pay the City royalties on residue gas or gas remaining after separation, extraction or processing operations, based upon the proceeds of a bona fide or arms length sale or the market value thereof, whichever is higher;
- (f) purporting to enter into a contract for the sale, delivery, transportation or processing of gas produced from the leased premises without the prior written approval of the City;
- (g) selling oil, gas or products produced from the leased lands to a subsidiary or affiliate without the City's prior written permission.
- 17. The foregoing breaches of the Leases were and are material and have directly and proximately caused substantial damages to the City and resulted in unjust benefits to Chesapeake and Total.

Count Two - Breach of the Implied Duty of Marketing

- 18. Fort Worth incorporates by reference all preceding paragraphs.
- 19. In the alternative to the claims set forth in Count One herein, the City brings claims against Chesapeake and Total for breaches of their respective implied duties of marketing. By virtue of their self-dealing and breaches, the City has suffered actual damages in amounts equal to the royalties which the City would have received in the past from the date of first production to termination of the Leases had Chesapeake had Total operated and administered the Leases as reasonable and prudent operators and accounted to the City for all royalty payments due the City on all production.

Count Three - Right To Terminate the Leases

- 20. Fort Worth incorporates by reference all preceding paragraphs.
- than thirty days after the end of the month following the month during which production takes place. The Leases further provide that should the Lessee fail to pay the City the royalty required under the Leases, the City may, elect to terminate the Leases by sending written notice to the Lessee. Although the City believes and maintains it has the right to give such notice to Chesapeake and Total at this time, the City seeks a declaratory judgment from the Court confirming that it has the right pursuant to the Leases to send notice of termination and that should the City exercise such right, the Leases terminate and are of no further force or effect unless within thirty days from the date of service of such notice, Chesapeake and Total each make, pay, or cause to be paid the proper royalty payments that are owed the City under the Leases. In addition, the City alleges that it would be equitable and just to award the City its costs and reasonable and necessary attorneys' fees in connection with its request for this declaratory relief.

Count Four - Declaratory Relief

- 22. Fort Worth incorporates by reference all preceding paragraphs.
- 23. The City, Chesapeake and Total are persons interested under one or more contracts and/or oil and gas leases.
- 24. On or about August 28, 2013, a representative of Chesapeake and Total gave certain employees of the City who were attempting to obtain information pertaining to the scope and extent of underpayment of royalties, a copy of a "Base Contract for the Sale and Purchase of Natural Gas" between Chesapeake Operating and CEMI.

Apparently Chesapeake contends (or may contend) that the City agreed to the sham arrangements between Chesapeake and its affiliate by failing to object to such purported contract within fifteen days after such contract was purportedly provided to the City. Alternatively, Chesapeake may contend that such delivery on August 28, 2013 constituted a trigger under paragraph 4(G) of the Leases – something the City denies. By letter dated September 23, 2013, the City advised Chesapeake that Chesapeake had failed on August 28, 2013 to deliver the proposed contract at least thirty days prior to the execution of that contract, that what was presented was not a complete copy of the proposed contract, and that what was delivered was not delivered to the City Manager by certified mail, as required by the Leases.

- 25. At no time did Chesapeake Operating, Total, or any affiliate provide the City with a complete copy of that contract thirty days prior to its execution on or about September 13, 2010.
- 26. The City therefore seeks the following declarations as to the rights and legal relations among and between the City, Chesapeake and Total:
 - (a) that neither Chesapeake nor Total may deduct any costs of any kind from royalty payments due the City from the date of first production to date;
 - (b) that the royalties due to the City under the Leases may not be reduced by any "post production costs", including "owner third party costs" or any charges directly or indirectly taken as a result of sales to CEMI or other Chesapeake affiliates;

- (c) that Chesapeake materially breached the Leases by selling oil, gas or products produced pursuant to the Leases to a subsidiary or affiliate of Lessee without the City's prior written permission;
- (d) that Chesapeake has failed to pay the City royalties on oil, gas and casinghead gas, together with any other liquid gaseous hydorcarbons, based upon the higher of the proceeds of the sale [provided such sale is an arms length transaction and does not involve any sale to a subsidiary or affiliate of Lessee], or the market value thereof;
- (e) that Chesapeake has failed to pay the City royalties on products produced pursuant to the Leases based upon the gross market value or proceeds of a bona fide arms length sale thereof, whichever is higher;
- (f) that Chesapeake has failed to pay the City royalties on residue gas or gas remaining after separation, extraction or processing operations, based upon the proceeds of a bona fide arms length sale or the market value thereof, whichever is higher;
- (g) that because Chesapeake and Total have failed to pay the City royalties as provided in the Leases, the City has the right to terminate each of the Leases pursuant to the Leases by filing a notice of termination with the County Clerk in the county where the leased premises are located and that each such lease will be terminated as of the date such notice of termination is filed with the County Clerk;

- (h) that Chesapeake and Total must provide the City free access at all times to Chesapeake and Total's books and records relative to the production and sale of oil, gas or other minerals from any of the leased premises; and
- (i) that it would be equitable and just to award the City its costs and reasonable and necessary attorneys' fees.

Count Five - Attorneys' Fees

- 27. Fort Worth incorporates by reference all preceding paragraphs.
- 28. As a result of the actions of Chesapeake and Total, including their respective breaches of the Leases, the City was forced to retain Ralph H. Duggins and the law firm of Cantey Hanger LLP to represent the City and to prosecute the City's claims. The City of Fort Worth therefore seeks a judgment against Chesapeake and Total for a reasonable fee to be determined in accordance with Rule 1.04(b) of the Texas Rules of Professional Conduct.

Prayer

WHEREFORE, Plaintiff prays that Chesapeake and Total be cited to appear and answer and that upon final hearing or trial, the City have and recover Judgment from Chesapeake and Total as follows:

- (a) an award of actual damages equal to the amount of royalties due and payable under the Leases through the date of any termination of the Leases;
- (b) judgment awarding the declaratory relief set forth in Counts Three and Four, including a declaration that the City may terminate the Leases;
- (c) an award of costs and reasonable and necessary attorneys' fees in connection with the City's claims for declaratory relief;

- (d) reasonable attorneys' fees in connection with the City's claims for breach of contract;
- (e) in the alternative to the damages sought in (a), actual damages suffered by the City as a result of the breach by Chesapeake and Total of their implied duties to market;
 - (f) pre and post-judgment interest at the highest lawful rate;
 - (g) all costs of suit; and
- (h) such other and further relief to which Plaintiff may show itself justly entitled.
