Some lawmakers have cast doubt on the veracity of this press release, which raises the following questions:

- Are you saying troopers found people with jars of feces waiting to enter the Senate gallery and told them that if they trashed the feces, they could go in?
- Wouldn't it have been clear that an individual carrying human waste - a biohazard - to a legislative proceeding intended to disrupt it an potentially dangerous way?
- Was any evidence gathered?
- Were any of the people in possession of urine and feces questioned?
- Can you put me in touch with a trooper who has first-hand knowledge of what the press release alleges?
- Who wrote the press release and who approved its publication?

Since that press release was the official word to the public by DPS, the agency should be willing to substantiate its claims.

7. Is there a DPS officer that was directly involved with the seizure of the jars of urine and feces that can speak to that and verify that this happened?

Tonight the Rise Up Texas group gathered on the East grounds at approximately 7 pm. 4 of the 5 people arrested yesterday plus Corey Williams were included in the 90 people in attendance.

They glued signs to sticks, taped signs to light poles and prepared to camp out with blankets.

They plan to return tomorrow around noon to block ingress into the Senate, flood the Chambers, and throw confetti. They were drawing plans for the first 3 floors of the Capitol and the grounds.

They intend to create disturbance by blocking ingresses, being loud, and forcing arrests. They adjourned around 930 pm.

The intelligence was gathered by Agent Phillips, Sergeant Cruz, Corporal Champion, Corporal Lytle, B shift troopers, Supervisor Cannon and the monitor room.

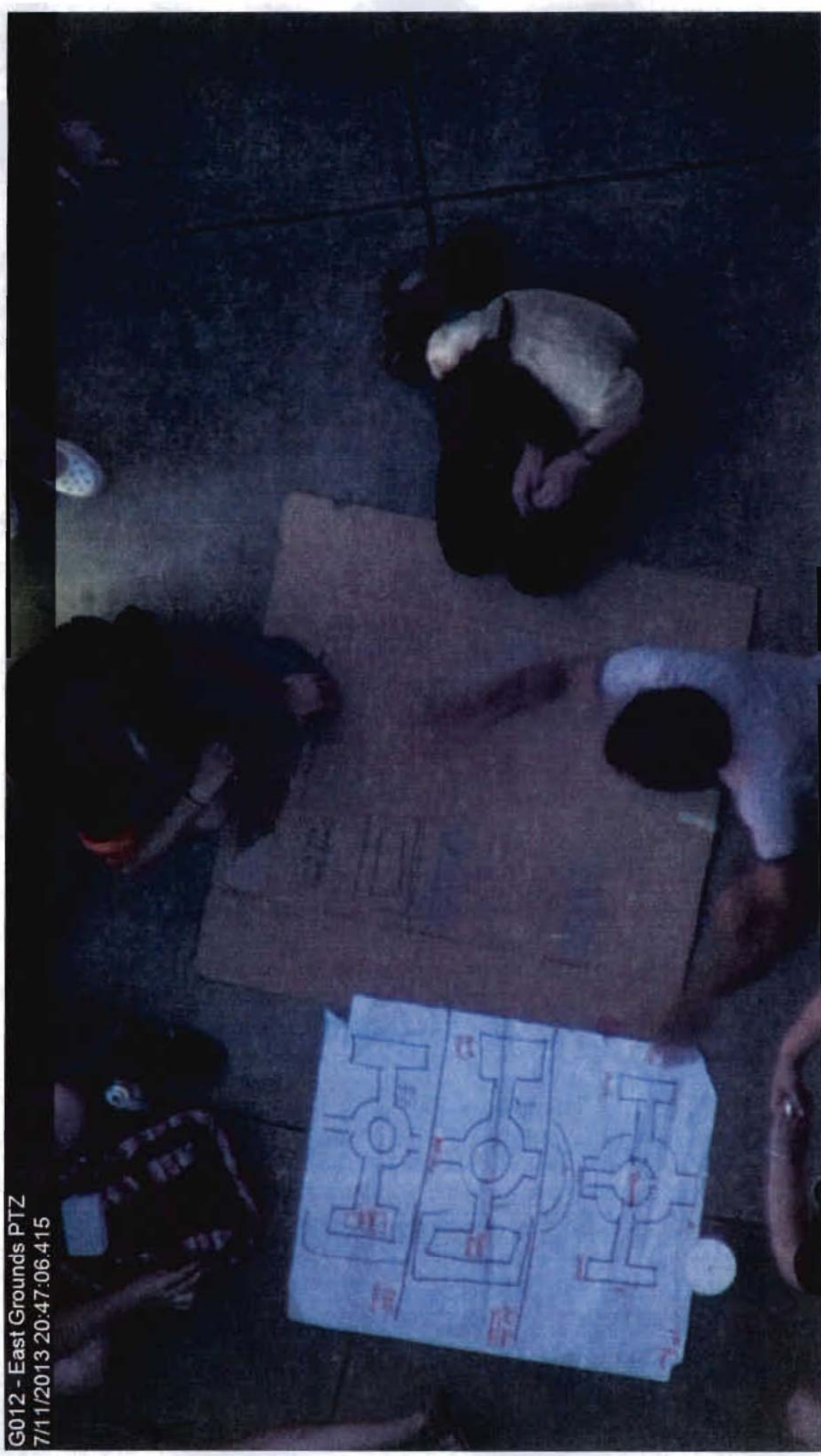

Senator says "blogosphere" tipped DPS off to potential violence

Texas Senate Administration chairman Kevin Eltife said Monday the Texas Department of Public Safety learned that some groups planned to heave projectiles into the Texas Senate gallery by monitoring online chatter in the days preceding Friday's debate.

Eltife said DPS set up a table to screen backpacks after monitoring the "blogosphere" and realized that a huge crowd would attend Friday's debate. Law enforcement officers found mention on the Internet of some groups who planned to throw projectiles, including urine and paint, onto the Senate chamber from the gallery, he said.

He stressed that DPS officials had told him that the aggressors were not part of the anti-abortion or abortion rights movements, but "third party groups" who wanted to make a statement. "They specifically said it was not Planned Parenthood...but some third party groups trying to stir things up," said Eltife.

DPS has been criticized for "confiscating" tampons, but Eltife said that action occurred after officers stopped a woman with a cache of "about 75" feminine hygiene products attempting to enter the Senate Gallery. News reporters on Friday could not find a trooper who could personally verify that jars of urine and feces were confiscated. A DPS press release claimed that 1 jar of urine, 18 jars of feces and three filled with paint were found by officers.

Eltife said DPS did not "confiscated" jars of urine and feces from protestors at the state Capitol, explaining that officers did not keep any of the material as evidence because they made no arrests.

"We didn't confiscate and keep the damn things. They either threw it away or they left," said Eltife. "They (DPS) didn't confiscate them and keep them as evidence."

Eltife praised DPS' handling of the tense situation, which resulted in 12 arrests, as well as the hundreds of advocates for both sides of the issue who observed the debate peacefully. "They did an incredible job," he said. "We were trying to protect the 500 people in the gallery who got to see the process work in a peaceful manner."

Eltife said it was important to "look at the night in total. Ninety-nine percent of the pro-choice and pro-life people behaved incredibly well," he said. But, "there are crazy people out there. We had seven knot-heads who chained themselves to the gallery railing. I was worried someone was going to go over the railing."

Dear Chairwoman Howard,

In response to your letter of July 15, 2013, regarding a number of questions relative to the events of July 12, 2013, the following answers are provided:

- It is still the Agency's contention that visitors to the Capitol attempted to bring urine and feces into the Senate gallery during the July 12th debate on House Bill 2? Yes
- If so, is this documented in an official Department report, and by which officer or officers? There is no official department report, DPS officers were busy assisting hundreds of citizens seeking entrance into the Senate gallery and when suspicious products or substances were discovered the person was advised to either discard the aforementioned items or they would be denied entrance into the gallery, as approved by the Senate.
- It is my understanding that any suspicious jars were required to be discarded, rather than confiscated. Is that correct, (Yes) or were there jars that were confiscated? (No) If so, what has happened to them?
- Why were suspicious jars not confiscated, when that seems to have been the protocol for handling other items such as feminine hygiene products and nutrition bars? None of the items were confiscated as it is not illegal to possess urine, feces, paint, feminine hygiene products, glitter or confetti. It would however, be illegal to use these objects as missiles thrown onto the Senate floor from the gallery. The urine and feces could have been used as bio-hazards and could have contained hepatitis or any number of bio-hazards. The jars themselves, regardless of content, could have been used as missiles and caused serious bodily injury.
- Were the names of visitors with suspicious jars documented? No
- Are there instances on this date where visitors with suspicious jars were allowed to enter the Senate gallery after having disposed of the contents? Yes

- If the allegations of suspicious jars are accurate, at what checkpoint(s) were they discovered: at one or more of the entrances to the Capitol, or at the entrance to the Senate gallery? All of the aforementioned items, with the exception of the bricks, were found at the Senate gallery entrance. The bricks were found in the Capitol Extension.
- If the July 12th allegations were not accurate, and due to a simple miscommunication brought about by the hectic nature of the day, is it the Department's intent to issue a correction? The press release of 12 July stands and as Director I stand solidly behind the integrity of the men and women who sacrificed their time and families to ensure those attending the democratic process at the Capitol these past weeks were able to do so in safe and secure conditions.

As you pointed out in your letter, there were thousands of citizens who "legitimately and lawfully exercised their right of democratic participation," unfortunately there were some, albeit a very small number, who came to our Capitol to create disharmony and mayhem. Had these individuals gained entrance into the Senate gallery with urine, feces, and other missiles and exercised opportunities to throw these items onto the Senate floor, I am sure I would be answering a totally different set of questions as to why the Department did not do more to protect the legislative members and public from missiles and bio-hazards. I hope these answers assist in setting the record straight.

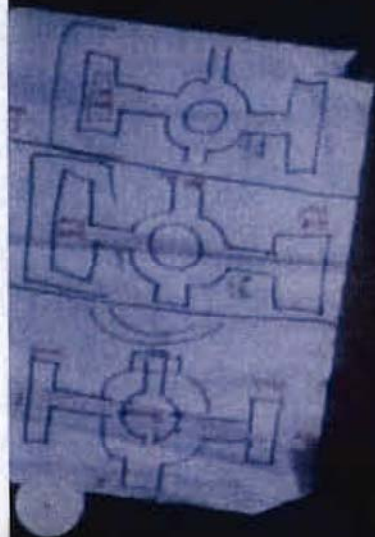
They intend to create disturbance by blocking ingresses, being loud, and forcing arrests. They adjourned around 930 pm.

This was taken from Abby Johnson's Facebook. Abby Johnson used to work for Planned Parenthood at a high level at one time but has changed her views on abortion and is a Prolife Advocate.....

"I just wanted to post something in preparation for tomorrow. I have had a couple of legitimately concerned abortion clinic workers (from Austin clinics) contact me to let me know what is being planned for tomorrow. **Both Planned Parenthood and NARAL are no longer encouraging their supporters to be civil and courteous.** These workers are telling me that **many are planning on getting arrested and being aggressive with proliferers (including physical contact because they don't think we will press charges).**
