- "Depends on if the Governor is positioning to run for President again. If he is, he will be trying to set a very conservative stage even if it is at the expense of the state."
- "Changing the School Accountability System"
- "Restore cuts."
- "The mix of drought, population growth, water demand and a healthy rainy day fund will result in action. A 'Rainy Day Fund' is supposed to be for emergency use, and the drought is definitely worthy."
- "Restorations more likely to happen in higher ed than HHS"
- "Only right-wing activists matter, and they will influence vouchers, more antichoice legislation."
- "Other than for grandstanding and posturing, the school finance lawsuit has no bearing on the current session."
- "If 'outside activists' mean folks other than legislators, then the business community, cities, and people of Texas could be considered outside activists."
- "Social issues will also be important to them, look for guns to also be an issue"
- "Read my lips, NO MORE TAXES! Such a sexy primary issue."

How would you rate the chances for revisions to the state's business margins tax during the regular session, given the rosy revenue predictions from the comptroller?

- "We are working on several tweaks to the margins tax. While complete exemptions have increased from 150,000 to 1 million for some businesses in Texas since 2006, other are paying up to 20 x more in taxes than prior to 2006."
- "Interest is increasing. The possibility of delivering a mortal blow to an unpopular business tax is stirring campaign stump speech writers into a froth"
- "The margins tax will continue to be tweaked but it will have nothing to do with the Comptroller's projections."
- "Let sleeping dogs lie."
- "The 'revision' will probably be making the \$1 million exemption permanent and removing some of the weird anomalies in the tax. Nothing big, like returning to a profits-based tax."
- "Any possible tax revisions considered will be minor, because the outcome of the pending school finance lawsuits will alter the tax landscape so why cut off your nose to spit your face!"
- "It was a BAD idea from the beginning."
- "A few tweaks but nothing major."
- "This leadership has shown a propensity for not tackling big issues."

- "Good chance that the small business exemption will be increased, but complete overhaul or repeal is unlikely."
- "The tax was hurriedly written and passed. There are several needed fixes that have been put off due to the bad economy."
- "But only minor changes that address some of the most obvious inequities."
- "Maybe they will rearrange the furniture, but large changes seem unlikely."
- "The revenue projection isn't rosy."
- "There's enough money to placate the most vocal critics, but wholesale repeal or replacement doesn't look likely."
- "The tax has caused more problems than solved, scrap it in now in order to better design a replacement, if necessary; with court action likely via school finance lawsuits a better circumstance for such action may not likely occur."
- "Republicans will avoid any issue that can be messaged into a 'he/she raised taxes.' For Republicans, every vote taken this session is an opening for a primary challenge."

With the coffers full, will lawmakers continue the governor's Emerging Technologies Fund and the Texas Enterprise Fund in the next budget?

- "Probably only the Texas Enterprise Fund as it has been a tremendous incentive for attracting business to our state distinguishing us from every other state in the nation."
- "MQS will win on this one."
- "The results speak for themselves it's supported by the house and senate and acts like an earmark to the members in the district."
- "The Enterprise fund is here to stay. The Emerging Tech fund may be on life support."
- "The ROI is proven. Let's keep the party going!"
- "Perry still has power."
- "Tax cutting fanaticism aside, cronies must be rewarded."
- "I hope NOT."
- "We need to stop corporate welfare it just doesn't work."
- "Perry will claim those programs as keys to the state's job development."
- "But there will be a fight over it"
- "Not without changes and lots of oversight"

- "We can only hope they won't."
- "Why wouldn't they? These are things that attract new business to provide our revenue stream."
- "Not in their current forms. The frost is off the Perry pumpkin. I don't see him getting carte blanche anymore."
- "Maybe, if legislators use the Rainy Day Fund for that, like they did in 2003 when creating the Enterprise Fund."
- "Presumably at a reduced level."
- "Or at least they damn sure ought to stop the slush fund pit."
- "The coffers aren't full, but they will continue the funds."
- "With an effort for added accountability and increased transparency...perhaps an attempt to limit projects eligible as well."
- "Perry will need to engage in more lobbying than in the past, but both funds should be safe."
- "Members smell blood in the water and a chance to cut spending somewhere is always fun for them."
- "These quasi government agencies are starting to pose a danger to

Republicans. The primary base does not believe in them."

• "Sure, they'll continue them. But they shouldn't--what a waste of money."

Will legislators make major changes to their budget practices this session, curtailing fund diversions, delayed payments and similar practices?

- "Define 'major'.... if you mean sound bite good and not really significant... then yes"
- "Legislators will do what is necessary to address the budgetary needs of our state."
- "They'll make some changes but total reform is unlikely"
- "Good reform eliminate diversions. More good campaign deliverables."
- "There will be some reform of fund diversions because the fee-payers are growing tired of paying into a system that doesn't pay them back. Other schemes like delayed payments will continue as means to certify the budget."
- "The game's been played like this for far longer than people care to admit; it didn't just happen last session. In essence, you can't teach an old dog, like the Lege, new tricks."
- "In theory, undoing the accounting tricks is good; in practice, it cuts the amount available to balance the budget. By a lot."
- "The genie is out of the bottle and can't be put back in one session!"

- "Gotta keep the accounting tricks in place just in case those rosy predictions turn out not so rosy the next budget cycle, as is often the case."
- "Cap spending at population and inflation."
- "And it is the only honest way to budget."
- "Depends what you mean by 'major'"
- "Too much pressure not to"
- "They will talk about it all session long, but fail to actually make the necessary changes."
- "Parks have been devastated because the license fee to which they are entitled and NEED for park improvements, infrastructure, etc. - will demand their monies be given to them. No more sweeping of funds."
- "A few"
- "Mavbe"
- "The rhetoric around diversions etc. doesn't really match the reality of what needs to occur to spend or redirect those funds. When it comes down to replacing the funds with pure GR many of the 'diversions' will be renamed to

something else or swept so it can be business as usual."

- "No, fund diversions, delayed payments and other practices allows them to fool the sheeple. Since it's worked forever, there's no incentive to change things now."
- "I think they'll take some good first steps without doing anything drastic."
- "Only to a degree. Expect them to try and have it all by spending on new items while employing a few accounting tricks."
- "They will build back in the cushion for future re-use."
- "Probably undo some of 2011's smoke and mirrors, but not all."
- "Presumably they will take a step toward reducing fund diversions and reverse formerly delayed payments."
- "They should but that dynamic will most likely be pushed by Republican leaders who are not fearful of legislative leaders or the Governor. In fact, why does anybody really care at all about what the Governor thinks."
- "It depends on educating all of the new members."
- "Minimally...a nod in that direction"
- "They won't make 'major' changes, but they'll make important ones. I would guess they'll begin curtailing some diversions, and reverse some of the one-time accounting tricks."

- "'Smoke and mirrors' is an insulting term for an important, legitimate process. Any responsible private business, when under pressure, delays its payables and accelerates its receivables and the State can and should (and does) do the same thing. It would be irresponsible in the extreme to prohibit those practices for future economic downturns. As for diversions and transparency? We'll see if members have the intestinal fortitude to tackle those, and if leadership is serious about making changes."
- "Can't afford it."
- "Some curtailment of the use of 'dedicated' revenues for funding of the general budget will have to happen, given the Speaker's comments."
- "Yes. If not now, when? If not this group, who?"
- "The Speaker's review of dedicated funds is laudable; however, those fund balances may be as high as they are because of legislative action, or in action, to not spend funds for those purposes."
- "Not just no hell no. You can't teach an old dog new tricks. Are you kidding me? Please."
- "It is too early to tell. There are deals/negotiations in progress, but most importantly the Guv and Lite Guv are making strategic decisions to impact the next election."
- "They will do some like diversions but not all"
