- "I suppose a surprise is possible, but unlikely. There is little interest in this election."

- "Blame has not quite settled in yet hard to tell. Now the Doctors without Borders program is going to get a lot of scrutiny."

What will be the law on same-sex marriages in Texas a year from now?

- "Texas will be the last state that defined marriage as one man-one woman to redefine it."

- "Legal by court mandate, but plenty of wailing and gnashing of teeth in the interim and post-decision."

- "The 5th Circuit will overturn the Texas law but the Supreme Court still will not have taken up the issue."
- "The Fifth Circuit has not spoken on this issue. Until either it or the U.S. Supreme Court reverses the Texas ban, same-sex marriage will continue to be illegal in Texas. It's not even a close call."
- "But it will be legal all around us and the Feds will stay out of it."
- "US Sup Ct will legalize it for all states, but a year from now it might remain unsettled."
- "In 30 years, we're going to look back at this law and say, 'what were we thinking?' and 'why did we care?""
- "It may take slightly longer than a year in Texas, where legal resistance will be vigorous, but same-sex marriage is inevitable as a new U.S. constitutional right."
