Dear Governor Abbott,

First of all, I want to thank you for all you are doing to help address the COVID-19 Pandemic which has infected Texas -- and virtually the whole world. As much as you are doing, I know you cannot do it alone.

I am writing to formally ask that you call a Special Session of the Legislature, so we can all do our work in helping to fight the biggest threat any of us have ever experienced.

I have talked to a lot of people, including many legislators -- Democrats and Republicans alike -- everyone is saying we will and must have a Special Session. I wholeheartedly agree. But only you can make the Special Session happen.

We must meet before hospitals and our health care system becomes overwhelmed and before our economy continues its decline. Let me also state, I am confident we can take the appropriate measures to prevent the spread of COVID-19 in the Capitol.

I am writing to let you know I believe every single legislator stands ready to help you. I have had the opportunity to work with you on many issues in the past, such as property tax relief. However, I doubt there will be a more important issue we will ever be able to work on than stopping the COVID-19 Pandemic.

I believe you should immediately direct every agency in state government, as well as leaders from our state's health care infrastructure, education, law enforcement, local government, etc. to immediately let you and all of us in the legislature know what they can do to help, if given the legislative authority.

One of my Republican colleagues suggested, for example, that we allow or direct Appraisal Districts around the state to use 2019 appraisals for 2020 property taxes. I agree with this approach, but we need to pass a law to make it happen.
