**PLAINTIFF'S ORIGINAL PETITION, APPLICATION FOR TEMPORARY  
RESTRAINING ORDER, APPLICATION FOR TEMPORARY INJUNCTION AND  
PERMANENT INJUNCTION, AND REQUEST FOR DECLARATORY RELIEF**

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COMES Chris Bell (Bell), Plaintiff, who files this Original Petition, Application for Temporary Restraining Order, Application for Temporary Injunction and Permanent Injunction, and Request for Declaratory Relief Against Hope Andrade (Andrade) In Her Official Capacity As Texas Secretary Of State and Stephanie Elaine Fridia-Simmons (Simmons).

**Discovery Level**

1. Discovery is intended to be conducted under Level 3, T.R.C.P. 190.4.

**Parties**

2. Bell is a resident of Harris County, Texas.
3. Andrade is an individual who serves as Texas Secretary of State. She may be served in person with process at the Texas State Capitol, Room 1E.8, Austin, Texas, 78701.

4. Simmons is an individual and a resident of Harris County, Texas. Simmons may be served in person with process at her place of business located at 8400 N. Sam Houston Pkwy., Suite 200, Houston, Texas, 77064.

**Venue**

5. Venue is proper in Travis County, Texas, because all or a substantial number of the acts or omissions complained of giving rise to this claim occurred in Travis County, Texas. Furthermore Andrade regularly carries out her official duties in Travis County, Texas. Tex. Civ. Prac. & Rem. Code §§15.002(a)(1-3).

**Jurisdiction**

6. This is a suit to enforce unambiguous requirements of the Texas Election Code (the Election Code) and to prevent a violation of those requirements. Election Code §273.081 specifically vests this Court with jurisdiction to enjoin the threatened violation: "A person who is being harmed by a violation of this code is entitled to appropriate injunctive relief to prevent the violation from continuing or occurring."

**Facts**

7. On June 4, 2008 a special election was called by the Governor of Texas to fill a vacancy in Texas State Senate District 17. Senate District 17 was left vacant with the resignation of Sen. Kyle Janek. The special election is to be held this approaching general election date, November 4, 2008. Candidates for this special election must have filed applications with the Secretary of State no later than 5:00 p.m. Friday, August 29, 2008. *Exhibit A.*

8. Plaintiff Bell properly filed his application to be on the ballot. However, on Friday, August 29, 2008, the exact same day as the deadline to file for the special election, Secretary of State Andrade certified the list of candidates to appear on the ballot for the Senate District 17 special election in apparent violation of the Election Code. *Exhibit B.*

9. Included on the list of candidates certified by Andrade is Defendant Stephanie Elaine Fridia-Simmons. *Exhibit B.* Ms. Simmons filed her application to be on the special election ballot on August 29, 2008. *Exhibit C.* Ms. Simmons stated in her application she has lived in Senate District 17 for eleven months at 3918 Emerald Lake Dr., Missouri City, Fort Bend County, Texas. *Exhibit C.* However, readily available public data shows that

Ms. Simmons has not lived at the aforementioned address (and by extension Senate District 17) for anywhere near that time period.

10. As recently as March 2008 Ms. Simmons was registered to vote in Harris County, Texas at 4123 Belgrade Dr., Houston, Harris County, Texas. *Exhibit D*. Ms. Simmons has been registered to vote at the aforementioned address in Harris County, Texas (*Senate District 13*) for at least the past fourteen (14) years, including through the March 2008 primary election. *Exhibit E*. Putting to rest any doubt that Ms. Simmons resided in Harris County, Texas in March 2008 is the sign-in sheet from the Harris County Precinct 318 Democratic Party Primary Election wherein Ms. Simmons affirmatively held herself out to be a valid voter in Harris County. *Exhibit F*.

11. Not until August 28, 2008, the day before the deadline to file for the Senate District 17 special election did Ms. Simmons attempt to reside in Senate District 17. At that time Ms. Simmons changed her voter registration to 3918 Emerald Lake Dr. Prior to that time there is no history whatsoever of Ms. Simmons voting in Fort Bend County. *Exhibit G*.

#### Law

12. Article 3, Section 6 of the Texas Constitution makes it abundantly clear that a candidate for the Texas Senate must have been a resident of the relevant district for the year prior to the election in question:

**No person shall be a Senator, unless he be a citizen of the United States, and, at the time of his election a qualified voter of this State, and shall have been a resident of this State five years next preceding his election, and the last year thereof a resident of the district for which he shall be chosen, and shall have attained the age of twenty-six years. (Emphasis added).**

The requirement that a senate candidate live in the district in question a year prior to the general election has long been acknowledged by Texas election authorities. See Election Law Op. No. DAD-19 (1982) (opining that if a candidate is not a resident of his senatorial district the preceding year to the election he is ineligible for the Senate under Article 3, Section 6 of the Texas Constitution).

13. Typically, competing candidates are allowed to review and challenge issues of eligibility based upon readily available public records via an administrative declaration of ineligibility. Tex. Elec. Code §145.003. In the instant case such a challenge would have

been submitted to the Texas Secretary of State. Tex. Elec. Code §203.006 and Tex. Elec. Code 145.003(c). However, as stated, Bell was not permitted in any way, shape, or form to submit such a challenge to the Secretary of State prior to the initial certification of the ballot. Andrade apparently certified the names to appear on the ballot immediately after 5:00 p.m. on the Friday proceeding a three-day holiday weekend; the same day as the deadline to file for the special election in question. There was simply no statutory requirement or reasonable justification to certify the ballot post-haste and deprive competing candidates the opportunity to review other applications. Tex. Elec. Code §141.032 (review of eligibility by certifying authority must be completed in five days).

14. Bell has been left with no choice but to file this judicial action seeking injunctive relief. Black letter law shows that Ms. Simmons is ineligible to be on the Senate District 17 special election ballot. Ms. Simmons voted in Harris County, outside of Senate District 17, as recently as this past March. A voter can vote in a former precinct only if the voter still resides in the same county. Tex. Elec. Code §11.004. Before casting a vote in an election, all voters must affirmatively state whether they reside in the same county as the polling station at which they present themselves. Tex. Elec. Code §63.0011. By definition, Ms. Simmons is ineligible to be on the ballot in question. Ms. Simmons cannot be a voter in one county, and then six months later change her address and be a candidate for a senate district in a different county a mere two months prior to the special election. See Article 3, Section 6 of the Texas Constitution.

#### **Injunctive Relief**

15. Bell incorporates the allegations of the above paragraphs.

16. Because Andrade's actions certifying the special election ballot violate the express requirements of eligibility contained in the Election Code, Bell will be irreparably harmed and afforded no adequate remedy at law if this Court does not provide immediate equitable relief. Bell seeks a temporary restraining order, temporary injunction, and permanent injunction, ordering Andrade to take whatever actions are necessary to decertify Simmons from the Senate District 17 special election ballot to the extent she was previously certified.

17. The need for immediate injunctive relief is paramount. Under Election Code §§145.094(a)(3) and 145.092(b) the deadline for omitting an ineligible candidate's name from the ballot is September 12, 2008 (53 days before the special election). As a result

Bell seeks an expedited trial on the merits for permanent injunctive relief and declaratory relief by September 12, 2008.

**Declaratory Relief**

18. Bell incorporates the allegations of the above paragraphs.

19. Bell seeks a declaratory judgment that Defendant Simmons has not been a resident of Senate District 17 for the one-year period preceding the November 4, 2008 special election to fill the current vacancy in Senate District 17 and is therefore ineligible to be on the ballot this Fall.

**Prayer**

20. Bell prays for judgment that (1) Andrade and her agents, servants, employees, representatives, and all other persons, or state actors in active concert or participation with Andrade, be temporarily restrained and then permanently enjoined from certifying Simmons' application to be on the Senate District 17 special election ballot; (2) Andrade be required to take necessary steps to decertify any conditional certification of the Senate District 17 ballot with Simmons' name as she is ineligible to stand for election and that the August 29, 2008 directive conditionally certifying Defendant Simmons be modified accordingly; (3) Defendant Simmons has not been a resident of Senate District 17 for the one-year period preceding the November 4, 2008 special election to fill the vacancy in Senate District 17 and is therefore declared ineligible to be on the ballot this Fall; and (4) Bell be granted such further relief to which he may be justly entitled.





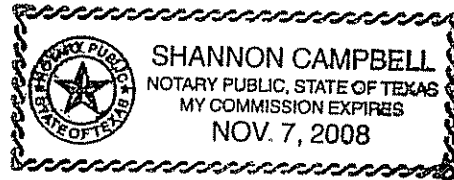

June 04, 2008

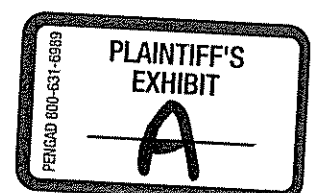

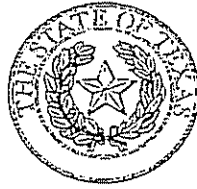
The senator elected in this special election will serve out the remainder of Sen. Janek's term, which expires Jan. 2011.
